

<b>Guest Investor Visa (nr. 24)</b>	
1	Dully filled and signed <b>application form</b> for guest investor visa (nr. 24)
2	Two recent passport size <b>photographs</b> in color with white background (3.5 cm by 4.5 cm ) not older than 3 months
3	Valid <b>passport</b> with the previous (old) passports (at least 2 blank pages in the valid passport are needed and the passport has to be issued within the previous 10 years). Passport must be valid until at least 3 months after the intended stay.
5	Valid <b>insurance</b> or equivalent financial coverage for the full range of health care benefits
6	A document certifying the address of the applicant's actual <b>accommodation</b> in Hungary
7	One of the following documents may serve as <b>proof of the purpose</b> of residence: <ul style="list-style-type: none"> <li>• Proof of acquisition of an <b>investment fund share of at least EUR 250 000</b> issued by a real estate fund registered by the Hungarian National Bank, or small-scale farmer/producer certificate,</li> <li>• <b>Proof of provision of a financial donation</b> in an amount of <b>at least 1 000 000 EUR</b> and for a purpose of educational, scientific research or artistic creation activities, to a higher education institution maintained by a public trust with a public-service mission.</li> </ul>
8	In case you are <b>not the holder of the investment yet</b> , the following must be attached to the application: <ul style="list-style-type: none"> <li>• a <b>statement</b> on which of the above-mentioned investments you plan to realize within 6 months of entering Hungary, and</li> <li>• a <b>certificate</b> issued by a foreign or Hungarian credit institution stating that the applicant has sufficient money for the investment.</li> </ul>
9	<b>Bank account certificate</b> with current balance and the <b>last 4 months bank statement</b> , counting from the date of your interview <b>or</b> a document on regular income issued by the tax authority
10	<b>Proof of income:</b> employment certificate, salary slip; if applicable.

**Family members can only apply for a D visa (purpose of family reunification) at the Embassy, if the main applicant has already applied for a residence permit in Hungary.**

Please note that **the visa for guest investors shall be withdrawn** by the immigration authority if the third-country national **does not realise the committed investment, or does not realise it within 6 months after the issuance of his/her visa** for guest investors.

NOTE: If the documents you are submitting are in a language other than English, **you need to have them translated in English** All the translation should be stamped by Iran's Judiciary and Ministry of Foreign Affairs. Translations must be no more than 1 year old.

**Issuing the visa is subject to the submission of the documents listed.** The Embassy reserves the right to request further documentation.

Original documents must be presented during the personal interview with the visa officer and **a copy also must be submitted.**
